Pharma Print, based in Debrecen, has for many years manufactured leaflets for the pharmaceutical and healthcare markets. Through this acquisition, Faller Packaging has expanded its strong network of production locations in Europe.

Pharma Print, a family-owned company with 70 employees, is a successful supplier of pharmaceutical package inserts to eastern European and international markets.
