The pharmaceutical packaging specialist, August Faller, continues to expand its production capacity: The company has invested in a new, state-of-the-art printing press at its head office in Waldkirch, Germany. The new equipment from the manufacturer Heidelberger Druckmaschinen is suitable for multicolour printing in up to seven colours, including UV coat application. "This gives us more options for high-quality, visually appealing packaging," explains Peter Ganter, Director of PSC Folding Cartons at August Faller. It's particularly important for 'over-the-counter' (OTC) products sold in pharmacies and supermarkets to be attractive.

## Large-format pharmaceutical packaging on trend

The new acquisition means that August Faller is also broadening the scope for the production of large-format medical packaging. "It's mainly the 3B format, measuring 70 x 100 centimetres that is gaining importance in the pharmaceutical industry," says Ganter. The reason for this is that the packaging has to include even more information but also additional flaps, for example to protect against interference or to add syringes or pens. "As an expert in individual custom-made products, it's really important to us that we are able to offer our customers even more options here." The additional production capacity will also help August Faller to be able to guarantee high availability for its entire product portfolio.
